Jellico Creek Baptist Church established August 1808 as an arm of the Cumberland River Baptist Church which is now known as the First Baptist Church, Barbourville, Kentucky. Organized as a Church on the third Saturday November 1814. Ministers present were Revs. John Catching, Peter Engle, W.M. England, Spencer Foley and Luke Williams.

Information and records are hard to find for the years between 1808, when the Church was established, and 1846, the first entry of minutes in book 1. Records obtained for years prior to 1846, and not a part of book 1, is marked "A", "B", "C" etc.

Records taken by the Rebels during the Civil War and missing pages of existing Church minutes creates a void in the activity of many members.

Some discrepancies are noted between the minutes and the roster of names. A member is assigned a number in the minutes and has a different number in the roster of names. This may have been as a result of the action taken in October 1899 when the "Old records of the Church was obtained from Knox County, Kentucky and copied for future reference."

Example #1; There were 82 members in 1846 according to the 3rd entry of book 1 minutes. #82 in the roster is Emily Moses who joined in May 1858 or 12 years later

Example #2; Mary Abbit was given #21 in minutes on joining Sept 1856, however in the roster of names she is listed as #63. (Eliza Lovet is #21)

In roster of names: Book 1 has one list of names in numerical order listing male and female together with husband & wife one number apart in many cases. Books 2, 3 and 4 has one list for male members & another list for female members with some additional information of when & how joined, dismissal, deaths etc. Also in book 4 when a female member is married, her maiden name is scratched thru and married name is inserted.

Book 1: Recorded minutes from Sept. 1847 thru March 1878

Book 2: Recorded minutes from Aug. 1878 thru Dec. 1890

Book 3: Recorded minutes from Jan. 1891 thru April 1908

Book 4: Recorded minutes from May 1908 thru June 1928

NOTES OF INTEREST

The earliest record in book 1 is dated 1846 with a list of names only-as follows; Wm. Criscillis, Charles G. Creekmore, Sollomon West, Sherad Kidd, John Campbell, Nathan Richman, B. R. Creekmore. (all listed in 1st 32 numbers - roster of names bk. 1)

The first record of a member joining is Henry Stephens - Sept 1848 rbl. --- He is not listed in the roster of names.

Feb. 1887; Mrs Lang, a lady Preacher, preached at Jellico Creek Baptist Church!!!!

June 1856; black Hannah #63 and black Mary #61 received by baptism.
